

# Baytown Fire Control, Prevention, & Emergency Medical Services District (FCPEMSD)

## PROPOSITION NO. 1:

Whether the Baytown Fire Control, Prevention, and Emergency Medical Services District should be continued for five (5) years and whether the fire control, prevention, and emergency medical services district sales and use tax should be continued for five (5) years.

## What is FCPEMSD?

FCPEMSD is a special district designed to incorporate



strategies set forth by the Baytown Fire Department and EMS, and adopted by the FCPEMSD Board for the enhancement of fire and emergency medical services in Baytown. This district may be utilized in many ways, but renewal would continue strategies that voters approved in the first five-year period. These strategies include:

- Personnel and capital expenditures;
- Fire protection/prevention programs;
- Specialized training; and
- Purchase and replacement of emergency vehicles, equipment and enhanced emergency communications programs.

## How much does it cost?

The current and proposed sales tax rate is 1/8 of 1%.



This means that for every \$100 purchase in Baytown, 12.5¢ is collected for FCPEMSD.

**Where does the money go?** Funds obtained through the sales tax are overseen by a seven-member citizen board. During the past five-year district, updates were presented to the community to ensure adopted strategies were being met.

Previous purchases made through FCPEMSD include:

- 2 Fire Department Pumper Trucks;
- 4 EMS Ambulances (5th on order);
- Automatic External Defibrillators (AED)
- EKG monitors and computer laptops;
- Improved stretchers, Medvaults, and other lifesaving EMS equipment;
- State of the art digital two-way radios;
- Design services for a state of the art fire training facility, located on 20 acres of land; and
- Salary and maintenance for an Assistant Training Officer (Fire) to facilitate state-mandated training and certifications.

## Baytown Crime Control & Prevention District (CCPD)

### PROPOSITION NO. 1

Whether the Baytown Crime Control and Prevention District should be continued for five (5) years and the crime control prevention district sales and use tax should be continued for five (5) years.

### What is CCPD?

CCPD is a special district designed to incorporate strategies set forth by the Baytown Police Department and adopted by the CCPD Board for the enhancement of public safety in Baytown. CCPD may be utilized in many ways, but the renewal would continue the strategies that voters approved in the first five-year period.

These strategies include:

- Personnel;
- Vehicle Acquisition/replacement; and
- Technology Improvements.



**How much does it cost?** The current and proposed sales tax rate is 1/8 of 1%. This means that for every \$100 purchase in Baytown, 12.5¢ is collected for CCPD.

**Where does the money go?** Funds obtained through the sales tax are overseen by a seven-member citizen board. During the past five-year district, updates were presented to the community to ensure adopted strategies were being met.

Previous purchases made through CCPD include:

- 2 additional Commercial Vehicle Enforcement Officers;
- 13 member "Hot Spot" unit;
- 23 fully equipped police vehicles;
- 50 Mobile Data Terminals (MDTs);
- Digital mobile video and Doppler radar equipment;
- License plate recognition equipment;
- Upgrades to specialized police software.
